



**Commercial Booth
Guidelines & Registration
September 24 & 25, 2022**

Online Registration available at valleyfest.org

1. Commercial booth is for a business with a public storefront. Commercial booth businesses may promote themselves through demonstrations and distribution of marketing materials. Items may be sold with prior written approval from Valleyfest. A free children's activity is to be provided.
2. Registration is \$410.00 per 10 ft. x 10 ft. booth space; or \$820 per 10 ft. by 30 ft. booth space. All materials and booth staff need to stay in booth space.
3. Booth Hours are 10:30AM-6:00PM September 24 and 11:00AM-4:00PM on September 25, 2022.
4. Commercial booths asked to stay both days, if not possible please notify Valleyfest at time of registration.
5. One (1) eight-foot table will be provided, please bring your own awning and chairs. **Limited Electrical outlets are available, call to inquire.**
6. Set up is Friday, September 23, 12:00-5:00PM, Saturday, September 24, 7:00-9:30AM and Sunday, September 25, 8:00-10:00AM.
7. Security will be provided September 23 and 24 and Valleyfest will take reasonable precautions to protect displays. The festival will assume no responsibility for any loss due to fire, weather, theft or other damage which might occur.
8. Guns, knives (including toy), generators, amplification or trailers are not allowed on site.
9. Compliance with county and/or state ordinance, taxes, and laws is the responsibility of participant.
10. Confirmation with more information will be sent out upon receipt of registration.
