The Miss Spokane Valley Court Program provides an opportunity for outstanding young women to be recognized for their achievements, as well as participate in Valleyfest and other events as appropriate.

General

- Be a full time, female, high school Sophomore or Junior;
- Have accumulated a grade point average of at least 3.0 at the time of application based on a 4.0 system, good citizenship, and school attendance;
- Be a resident of Spokane Valley or surrounding communities;
- Be able to meet the time commitment and job responsibilities as set forth by Valleyfest;
- Refrain from possessing, selling or any personal involvement with alcohol, any controlled substance, or non-prescription mind, personality, or mood altering substance from the time I sign this document through my tenure as royalty;
- Absolutely no use or possession of tobacco products while representing Valleyfest and the Miss Spokane Valley Program;
- Refrain from engaging in gossip at all times;
- Maintain a pleasant attitude at all events during year of reign.

Cell Phones & Technology

- Respond in a timely manner to all event/appearance requests and any Miss Spokane Valley related engagement (via email, phone call, and/or text message);
- The court must respond to the director(s) in a timely manner, for the sake of scheduling and communication.
- Refrain from using cell phones during Valleyfest events. Phones must be silenced and out of sight during events.

Social Media

- Photos and posts should be in good taste and **approved by Valleyfest**;
- Absolutely no illegal substances (drugs/ alcohol) or inappropriate language or gestures should be visible (you cannot post or be tagged in a post);
- You must allow Valleyfest to follow you on all your social media accounts (Facebook, Instagram, Twitter, Pinterest, LinkedIn, etc.).

Appearance & Attire

- Good personal hygiene is to be maintained at all times;
- Hair should be neat and clean, and out of your face,
- Agreed upon clothing should be clean and good repair,
- Denim should not have any holes/distressed,
- Tops should not be cropped or spaghetti straps,
- Crowns/Sashes are not to be worn unless in the presence of a designated Miss Spokane Valley chaperone at a Valleyfest approved event.

Attendance

- The court is expected to attend all scheduled events,
- In the event that they cannot attend an agreed upon event they need to provide as much notice as possible to the director/chaperone assigned to the event.

Schedule/Events

Parades

- We attend 5-8 parades per year, and this number is subject to change. The court is expected to arrive to the designated meeting location on time, in the agreed upon attire. Individual instructions for each parade is emailed in advance.
- The court maybe asked to stay at the event after the parade to attend luncheons, awards, or other events.

Float Preparations

- The court is expected to develop and use a float routine, and to help build the remainder of the float.

Valleyfest Weekend

- The court should expect to spend Friday Night at the parade (09/25) full days both Saturday (9/26) and Sunday (9/27) of Valleyfest weekend at the event.

Community Service

- The court will be expected to attend community service events, such as cycle celebration, the Pancake Breakfast, Tree Lighting, etc, the court will plan to and agreed upon additional opportunities to serve the community during their reign.
- The court will also help plan and prepare the pageants, and clinics for the following year.

Parents/ Guardians

- Parents/Guardians are welcome to support the program. There are opportunities to help at events, such as walking with the float in a parade or assisting with chaperoning.
- When with a chaperone, they must have a visual hand off of the girls to their designated parent, unless they have driven themselves, etc. Ultimately we want to ensure safety of the court when at events.
