Political Booth Guidelines

1. A Political party booth is to promote the platform and candidates of their party through brochures and materials. Candidates that want to be present must purchase a Candidate booth for \$140. This is a non-fundraising, non-sales booth and a free children's activity is to be provided.
2. Must be a registered Spokane County Major Political Party.
3. Registration is \$140 per 10 ft. x 10 ft. booth space. All materials and booth staff need to stay in booth space.
4. Booth Hours are 10:30AM-6:00PM September 26 and 11:00AM-4:00PM on September 27, 2026.
5. Political booths are required to stay both days.
6. One (1) eight foot table will be provided, please bring your own awning and chairs.
7. Booth set up is Friday, September 25, 12:00-5:00PM, Saturday, September 26, 7:00-9:30AM and Sunday, September 27, 8:00-10:00AM.
8. Security will be provided September 25 and 26 and Valleyfest will take reasonable precautions to protect displays. The festival will assume no responsibility for any loss due to fire, weather, theft, or other damage which might occur.
9. Guns, knives (including toy), generators, amplification or trailers are not allowed on site.
10. Compliance with county and/or state ordinance, taxes, and laws is the responsibility of participant.
11. Confirmation with more information will be sent out upon receipt of registration.

Entry Deadline: Registrations after September 7, 2026 are accepted as space allows.
